- 1. Pursuant to the orders passed by a coordinate bench of this Court on 28.09.2018 and 04.04.2022, status reports have been prepared on behalf of respondents no.2 and 6, as also on behalf of respondents no.3, 5 and 7.
- 1.1. Counsels appearing for the said respondents say that they have

- 4.1. This team is represented by Ms Ambika Mathur, Advocate. The concerned representative of Tech Mahindra shall also participate in the deliberations held for removing the glitches in the existing system.

well as Tech Mahindra.

- 5.1. We would exhort, as indicated above, the technical teams of both Infosys and Tech Mahindra, to also, participate in the meetings.
