
## Trend of Cancellation and Revocation of GST Registration







## Invoice Count as per Turnover Slabs (at GSTIN Level)












### Month wise Tax Collection Trend\*





## Turnover Slabs and Cash Payment Trends






## Cumulative Trend of Users' Registration on E-Way Bill Portal (GSTIN holder, Transporters and Unregistered Persons)

## Trend of E-way Bill Generation (1st April 2023 - 26th June 2023)








## Trend of E-Invoice Generation


No. of IRN generated




No. of GSTINs generating IRNs
