NOTIFICATION

New Delhi, the December, 2023

G.S.R.----(E).- In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Indian Corporate Law Service Rules, 2015 and Indian Corporate Law Service (Amendment) Rules, 2017, namely:-

1. **Short title and commencement.** - (1) These rules may be called the Indian Corporate Law Service (Amendment) Rules, 2023.

(2). They shall come into force on the date of their publication in the Official Gazette.

2. In the Indian Corporate Law Service Rules, 2015 read with Indian Corporate Law Service (Amendment) Rules, 2017, in the table under para (ii) of the Schedule-II, -

(i) in column 5 of serial number (5), for the words, letter and figures "Junior Time Scale officers with four years regular service in the level 10 in Pay Matrix Rs. 56,100-1,77,500", the words, letter and figures "Junior Time Scale officers with five years regular service in the level 10 in Pay Matrix Rs. 56,100-1,77,500" shall be substituted.

(ii) in column 5 of serial number (6), for the words, letter and figures mentioned in column 1 of the table below, the words, letter and figures mentioned in column 2 of the table below, shall be substituted-
