A notification dated 15th October 2020 states that taxpayers whose aggregate annual turnover (AATO) exceeds Rs 5 Crore shall include at least a 6-digit HSN code in an e-invoice or e-Waybill and other taxpayers shall include at least a 4-digit HSN code.
