Central Goods and Services Tax (CGST) and Central Excise, Mumbai Zone has launched a dedicated Grievance Redressal Mechanism to help taxpayers facing issues during Goods and Services Tax (GST) registration. Applicants under the Central jurisdiction who are experiencing delays or problems can now submit their grievances via email to: reg-cgstmz[at]gov[dot]in. This initiative aims to simplify the registration process, reduce delays, and improve ease of doing business. This was stated in an official press release issued by Principal Additional Director General, Directorate of Taxpayer Services, Mumbai Zonal Unit, Shri Sumit Kumar.

#### How to Raise a GST Registration Complaint?

If you are encountering issues while applying for GST registration, send an email including the following:

- 1. Application Reference Number (ARN)
- 2. Jurisdiction (whether you are under Centre or State)
- 3. Brief and Clear description of the issue faced

Complaints will be addressed by the concerned department and applicants will be kept informed.
